- Perron Group has sold a portion of the shares for the Town Centre premises Belmont Forum. This is not a physical sale of land, but rather stakes in the business centre operations.
- The City has paid for the advertising of this scheme amendment. When an applicant lodges a Scheme Amendment application, the City provides the applicant a fee breakdown, and there are opportunities for the City to request that the applicant reimburse the City for any advertising costs.
- There is minimal risk that the report will be revisited for further review, as the Minister is likely to make a final decision on the amendment.

- The Director Corporate and Governance confirmed that future major policy changes will be initially discussed at an Information Forum prior to coming to Council for consideration.
- One of the goals for this policy update was to provide an overall assessment when considering procurement submissions. The removal of the 10% premium for local businesses allows the City to include a wider range of considerations to support local businesses.
- The Director Corporate and Governance confirmed links to the Tenders Register could be inserted in future reports.
- The City has removed price as a weighted assessment factor in procurement, as quite often the value to the City is not limited to a dollar value.
- Page 173 lists 6 West Australian Local Governments who were among a number of Local Governments that the City benchmarked the delegations for accepting tenders against. This list is only inclusive of Local Governments who responded to the City.
- The Procurement Advisory Group (PAU) is an internal working group. The PAU operates to assess the tender documentation that comes from the Tender Panel, and then makes a recommendation to the Chief Executive Officer to accept or reject the tender. It then either comes to Council for a decision or is signed by the Chief Executive Officer under his delegation.
- Elected Members are privy to the same tender documentation as the PAU. There was no specific report evaluated by the PAU that prompted this policy change.
- A number of Local Government Finance Managers engage in a discussion-based working group. The information included for benchmarking in this report was obtained in open discussion.
- A Purchasing Policy and delegations are two separate considerations, and the delegation can vary significantly from the policy. Council Purchasing Policy can require procurement processes over a certain amount to go to tender. However, the Chief Executive Officer can still have delegation in excess of that amount to award a tender.





# **Need for Strategic Planning**



- Modified amendment proposes to change the permissibility of X uses:
  - Education Establishment
  - Health Centre
  - Motel
  - Nursing Home
  - Reception Centre
  - Serviced Apartment
- Significant change to the local planning framework.
- All uses apart from 'Reception Centre' are inconsistent with the scheme objective
- Strategic Planning (Precinct Structure Plan) is required.

Additional Uses	Cityof Belmont

- Additional Uses are no longer proposed.
- Motor Vehicle Wash inappropriate for open air parking areas or at a large scale.
- Studio includes both a workroom and a sales area. Unregulated workroom spaces could operate at a scale inconsistent with scheme objectives.
- Without controls in LPS 15, officers would have limited ability to manage the scale and nature of these uses.

# Land Uses to be Changed to 'P'



- 'P' uses do not require approval if they comply with the local planning framework.
- 'Art Gallery' no specific parking requirements included in LPS 15.
- 'Consulting Rooms' already exempt if no more than 60% of the ground floor windows are obscure.
- `Liquor Store Small' There are matters (e.g. social impacts) that warrant consideration.

# **Officer Recommendation and Next Steps**



- It is recommended that Council does not support modified Amendment No. 21.
- Following the OCM, officers will forward Council's recommendation to the WAPC for final determination.
